

World Language Grants



What grants are available?

Each year FLAM awards up to two \$500 grants, depending on applications received.

Who is eligible?

FLAM members (individuals or a collaborative), K-20, who have been in the organization for at least the last two years, and who are/will be teaching in Missouri during the year of the grant, current Executive Board and Awards Committee Members excluded.

What is the purpose of the grant?

The purpose of the grant is to support teachers financially in projects for improvement of instruction, either for significant professional development, like conference attendance, or for innovative projects in the classroom. Assessment projects, such as the Seal of Biliteracy, will also be considered.

What may be funded through the grant?

The grant money may be used for innovative classroom projects, nationally recognized World Language assessment fees and related supplies, realia, special classroom materials and supplies, travel, meals, lodging, conference registration, and admission fees.

What are my responsibilities if I am awarded a grant?

Grant winners agree to present a session at the next FLAM fall conference explaining how they used their grant money. Grant winners must also write an article about their grant for the FLAM website.

How will the grant be reimbursed?

According to the process for disbursement of the funds, original receipts will be required for final reimbursement. The FLAM Treasurer will make reimbursements by check.

FLAM will not provide a credit card for the awardee's use in purchasing the items in the grant.

Applicants are to articulate their grant proposal addressing the different criteria listed in the scoring rubric below:
